# 4-H HORSE PROJECT IDENTIFICATION APPLICATION

MUST BE ON FILE 120 DAYS PRIOR TO ANY HORSE EVENT. MUST RESUBMIT APPLICATION EACH PROGRAM YEAR. REPORT ANY CHANGE IMMEDIATELY SO THE FILE AT 4-H OFFICE STAYS CURRENT. NOTIFY THE 4-H OFFICE WHEN A HORSE IS SOLD OR A NEW HORSE IS BOUGHT WHEN IT OCCURS. AN APPLICATION FOR EACH HORSE OWNED OR LEASED BY THE 4-H MEMBER MUST BE ON FILE AT THE 4-H OFFICE.

**IMPORTANT: MEMBERS WANTING TO PARTICIPATE IN OTHER COUNTY, REGION OR STATE HORSE SHOWS, PLAY DAYS, ETC., MUST FOLLOW THAT ENTITY'S RULES. THE SUTTER/YUBA COUNTIES 4-H OFFICE HAS NO AUTHORITY OR JURISDICTION OVER ANY OTHER ENTITY'S RULES/POLICIES.**
